ANNEXURE

ELIGIBILITY – By transfer on deputation from:

- (i) Officer of the Indian Customs and Central Excise Service Class I holding analogous post.
 - (ii) Officer of the Indian Customs and Central Excise Class I with 5 years service in the grade pay of Rs. 5400/-.
 - (iii) Officers who have put in not less than 8 years service in any of the following Posts: -
 - (a) Superintendents of Central Excise Class II,
 - (b) Appraisers in the Customs Department.
- (Period of deputation ordinarily shall not exceeding three years)

TERMS AND CONDITIONS FOR SELECTION :-

1. Normally on terms and condition of deputation from posts having same/ identical scale of pay and responsibility.
2. The term of deputation is ordinarily not exceeding three years.
3. The candidate should be a graduate. (Desirable).
4. The maximum age limit for appointment by deputation shall not be exceeding 56 years as on the closing date of receipt of applications.
5. Previous experience in same or allied field is preferable.
6. Selected candidate will be informed and adequate time will be allowed for the preparation.
7. Names of officers who have worked in any SEZ and have not completed cooling off period of 3 years, may not be recommended.
