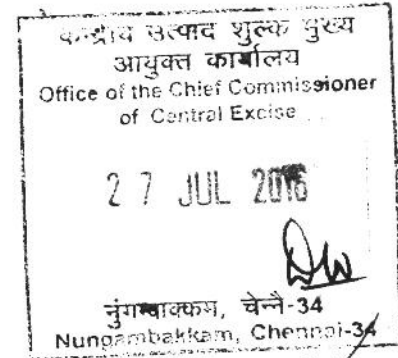

It is proposed to draw a panel of officers to fill up the following vacancies in the grade of Senior Intelligence Officer and Intelligence Officers in the Zonal Unit of DGCEI, Chennai and its Regional units at Coimbatore, Madurai and Trichy.

2. These posts will be filled up on deputation basis from the officers of equivalent grades of Central Excise and Service Tax usually for a period not exceeding 5 years in the Pay Band PB2 9300 - 34800 with Grade Pay Rs.4800 / Rs.5400 for SIOs (with corresponding matrix in 7TH CPC) and Grade Pay Rs.4600 / Rs.4800 for IOs (with corresponding matrix in 7TH CPC). As per the recruitment rules, the willing officer should have put in a minimum of three years of service in the grade. **The officer selected will be entitled to draw special allowance as per existing rules.** Officers who are selected however will have to make their own arrangements for residential accommodation. Normally, the deputation in respect of SIOs / IOs is for a period of five years which can be extendable by another two years subject

to the willingness of the officers, his/her performance, concurrence of his / her parent Commissionerate and approval of the Competent Authority.


3. It may please be made clear to the officers that option once exercised will be final and in the event of selection in this Directorate, they will not be allowed to withdraw the same. The minimum service requirement will be condoned if found otherwise suitable to work in this Directorate.

4. It is requested that this circular may please be brought to the notice of all the formations under your jurisdiction and the applications of willing officers may be forwarded to this office. While forwarding the names, the following information in respect of the officers may please be furnished.

- i) Complete Bio-data and willingness letter of the officer along with the History of previous postings
- ii) APAR Gradings for the last 5 years duly verified and attested by the Additional / Joint Commissioner (P&V)
- iii) Vigilance Clearance Certificate; and
- iv) No Objection from the Competent authority to relieve the officer in the even of his / her selection.
