CIRCULAR

Sub: Appointment of Superintendent on deputation basis in the Directorate of Logistics, Customs & Central Excise, N. Delhi-reg.

Two posts of Superintendent in the pay scale of Rs. 9300-34800 4800/5400 Grade pay are likely to fall vacant in the Directorate of Logistics, Customs & Central Excise, New Delhi. All Group 'B' Gazetted officers in the analogous Pay Scale, working in the Commissionerate/ Directorate/Custom House under Central Board of Excise & Customs are eligible for appointment on deputation to this post. The period of deputation is initially three years and can be extended by one year at the discretion of the Appointing Authority and for a further period of one year on mutually agreed basis.

2. Officers who apply for the said post will not be allowed to withdraw their candidature subsequently. However as and when a situation arises a premature reversion to his parent Commissionerate/Directorate may be given to the officer.

3. It is requested that names of suitable and willing officers along with their APARs grading for last five (5) years, Vigilance Clearance and History of Posting may be forwarded to this office **latest by 15.07.2016**, along with "No Objection Certificate" from the concerned Commissionerate/Directorate.
