**Subject:-Preparation of panel for appointment of Senior Intelligence Officers/ Intelligence Officers in the Directorate of Revenue Intelligence, Bangalore on Deputation Basis - Reg.**

This office is in the process of drawing up a panel of suitable candidates for filling up posts of Senior Intelligence Officer / Intelligence Officers on Deputation basis at DRI, Bangalore. These posts will be filled up on deputation

basis from the officers of equivalent grades of Customs, Central Excise and Service Tax in the Pay Scale of Rs.9300 – Rs.34800 (Pay Band-2) + Rs.4600 / 4800 for Senior Intelligence Officer and Pay Scale of Rs.9300 – Rs.34800 (Pay Band-2) + Rs.4200 for Intelligence Officer.

2. The Officers selected on Deputation basis, on appointment, will be entitled for Special Pay of 10% of the basic pay as defined in FR 9(21)(a)(I) in the revised pay scale subject to prescribed ceiling limit as admissible and they have to make their own arrangements for accommodation. Normally, the deputation is for a period of five years, which can be extendable by another two years, subject to willingness of the officers, his/her performance, concurrence of their parent Commissionerates and approval of the Competent Authority. It may be made clear to the willing officers that the option once exercised would be final and in the event of selection, they will not be allowed to withdraw the same.

3. Further, as per Para IV of Ministry's F.No.A-35017/28/92.AD.III.B. dated 30.6.1994 officers posted in certain charges/organizations/assignments are required to complete the "cooling off" period of not less than two years before posting in Directorate of Revenue Intelligence. However, the concerned Chief Commissioner of Customs/Central Excise has been given the power to relax the "Cooling off" period.

4. It is requested that the circular may please be brought to the notice of all the formations under your jurisdiction and the application of willing officers be forwarded to this office. While forwarding the names of willing officers, the following information in respect of them may be furnished.


- (i) Complete Bio-data and willingness of the officer alongwith history of previous postings;
- (ii). ACR grading for the last 5 years duly verified and attested by the Additional/Joint Commissioner (P & V);

(iii). Vigilance Clearance and

(iv). No objection from Cadre Controlling Authority to relieve the officer in the event of his selection.
