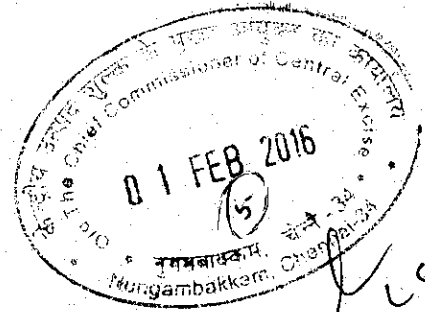

This is to inform you that the Sanctioned Strength of Central Excise Superintendents on deputation to C.S.I. Airport, Mumbai is 56. However, only 10 Superintendents are at present working on deputation from various Central Excise Commissionerates leaving 46 vacancies.

Similarly, the Sanctioned Strength of Central Excise Inspectors on deputation to C.S.I. Airport, Mumbai is 67. However, only 02 Inspectors are at present working on deputation from various Central Excise Commissionerates leaving 65 vacancies.


