Chennai Petroleum Corporation Limited (CPCL) is a group company of Indian Oil Corporation Limited and also a Central Public Sector Undertaking in the field of hydrocarbon processing. It has a total refining capacity of 11.5 Million Metric Tonnes Per Annum (MMTPA) with a 10.5 MMTPA refinery at Manali, Chennai and a 1.0 MMTPA refinery at Panangudi, near Nagapattinam (south Tamil Nadu).

CPCL has a full-fledged Vigilance Department, headed by a Chief Vigilance Officer, who is a senior Indian Revenue Service Officer, on deputation. At present, there is a requirement for Vigilance Officer at the level of Deputy Manager, on deputation basis. The candidate is expected to have three years of related experience in the functions of handling the matters relating to Vigilance, Anti-corruption and Disciplinary Proceedings.

The place of posting will be at Chennai. The initial period of deputation would be three years and subject to further extension of two years with the consent of both the organizations. The pay, allowances and perquisites will be guided by the Department of Personnel & Training, Ministry of Personnel, Public Grievances and Pension OM No.372/21/2009-AVD-III dated 12.10.2010.

The current pay scale for Deputy Manager is ₹32900-58000.

It is requested that the names of suitable and willing candidates, fulfilling the above mentioned requirements/service criteria may be forwarded to us along with their (a) up-to-date bio-data, (b) copies of ACR dossiers for the past five years and (c) copies of vigilance clearance certificates.
