2. The First Nominated Link Officer, and, in his absence, the Second Nominated Link Officer, as detailed above shall stand assigned the additional charge of the respective Officers mentioned in Col. (2) of Table-1 & Table-2 above whenever the Officers mentioned in Col. (2) of Table-1 & Table-2 above proceed on leave, transfer or is absent for any reason.

In terms of Board's Officer Order No: 1/2014 dated 28.08.2014 (issued from F.No.390/Review/49/2014-JC), the Commissioner being assigned the administrative charge of the Commissionerate i.e., the First Nominated Link Officer & in his absence the Second Nominated Link Officer would function as member of the Committee for the purpose of review of orders passed by Commissioner (Appeals).

4. Notwithstanding the above, Commissioner, LTU is assigned the charge of Commissioner, Chennai-III *for the purpose of review of orders passed by Commissioner (Appeals) relating to Puducherry Commissionerate* with immediate effect and until further orders.
