**Sub: Induction Course for Newly Appointed Inspectors of Central Excise -
 Nomination of Officers - Reg.**

Kind reference is invited to the letter C.No: II/39/103/2013-CCA-Estt., dated 22.12.2015 wherein it was informed that 278 Direct Recruit Inspector (Central Excise) have joined in various Zones / Commissionerates in the Cadre Control Zone of Tamilnadu & Puducherry and NACEN, Chennai has been requested to impart Induction training for these officers.

2. In this regard, National Academy of Customs, Excise and Narcotics, (NACEN), Chennai is proposing to conduct a series of "Induction Courses for newly appointed Inspectors of Central Excise and Service Tax" of 06 (six) weeks duration in 06 (six) to 07 (seven) Batches of 65 (sixty five) officers each for the newly appointed Inspectors of Central Excise and Service Tax. The curriculum of training will include the provisions of various statutes relating to Customs, Central Excise and Service Tax and certain allied acts like IPC, Cr.P.C etc., including training for 02 (two) weeks in "Physical Fitness, Drill, Arms including Firing" at the Recruit Training Centre, (RTC), CISF, Arakkonam. The 04 (four) week Induction Courses for newly appointed Inspectors of Central Excise and Service Tax will be conducted for a Batch size of about 65 (sixty five) officers at this academy. The First Batch of 06 (six) week training is proposed from 04th January 2016 to 12th February 2016 and the Second Batch is proposed from 18th January 2016 to 26th February 2016.

3. In this regard, it is requested that all Commissioners falling under your Cadre Controlling jurisdiction may please be suitably advised to nominate newly recruited Inspectors for each batch of the said Induction Courses beginning in **January 2016**.
4. NACEN, Chennai will be providing Hostel facilities for all the trainee officers at the Central Revenue Quarters, Anna Nagar, Chennai - 600 040.
