Sub: Posting of Air Customs Officers to Chennai Anna International Airport against 25% Quota-Reg.

Please refer to Ministry's letter F.No.A-11019/102/91-Ad-IV dated 21.10.1993.

In terms of the said letter, 24 posts of Air Customs Officers in Chennai Anna International Airport is to be filled from amongst Inspector (Preventive Officer) from the above mentioned Central Excise Commissionerate.

However, all the 24 posts are lying vacant as on date, as no officers have been posted to Chennai Anna International Airport, on deputation by the concerned Central Excise Officers since long time.

Accordingly, you are requested to give wide publicity and to send a panel of officers for appointment against 25% quota. The panel may be sent to this office at the latest by 15.11.2017. However, if no one in your Zone is interested the same may also be intimated to this office.
