Sub: Review DPC to review the Supplementary DPC for the year 2007-2008 held on 04.10.2007 – Notional promotion to the grade of Superintendent of Central Excise – Reg.

A review DPC was held on 04.12.2017 to review the Supplementary DPC for the year 2007-2008 (held on 04.10.2007) for promotion to the grade of Superintendent of Central Excise and to implement the order dated 14.09.2016 of Hon'ble CAT, Madras Bench in O.A.No.310/01926/2014. Consequent to this, Shri Jeeju Francis, (Emp Code-2649) is notionally promoted to the grade of Superintendent on regular basis with effect from 15.10.2007 on par with his junior Smt T.G. Geetha, (Emp code 4317).

2. Further, in the Zonal Seniority list of Superintendents, Shri Jeeju Francis will be placed above Smt T.G. Geetha (Emp Code-4317) and below Shri Jesu Chandrabose (Emp Code-1858) Superintendents.

3. Shri Jeeju Francis, Superintendent, Coimbatore is not eligible for arrears of pay and allowances consequent to the notional promotion. Further, as the officer had been granted first ACP w.e.f 26.02.2003, he is not entitled for any pay fixation benefits.

4. Further, the notional promotion now ordered is subject to the outcome of the decision in the cases pending before various judicial fora.
