2. While reporting, the candidate is required to submit the duly filled in Attestation forms (enclosed) in the prescribed proforma in **two sets in original without fail** along with **original** certificates in proof of:

- (i) Date of Birth
- (ii) Educational Qualifications
- (iii) Community Certificate, if applicable
- (iv) PH/ Ex- Serviceman Certificate, if applicable
- (v) Any other relevant document (which the candidate feels is necessary)

3. Also please find enclosed the format for Identification and Character Certificate (The same is **required to be obtained from two different gazetted officers**)


who have known the candidate for a minimum period of two years) in two sets in original which are to be submitted duly certified at the time of reporting this office.

4. After having completed Document Verification, the candidate will be subjected to Medical Examination and thereafter they will undergo Physical Endurance Test which will include walking and cycling. Candidate has to make their own arrangement for cycle.
5. Also, if the candidate has been issued with any Show Cause Notice (SCN), the reply of SCN along with proof of having sent the reply to the SSC should be brought at the time of verification without fail.
6. The candidate is also required to come prepared to stay for **3 working days** for completion of the required formalities. It may be noted that the candidate has to make their own arrangements for board and lodging during the stay. No travelling or other expenses will be paid by the Department for attending the Certificate verification and physical endurance test.
7. It may please be noted that any request from the candidate for rescheduling of dates will not be entertained.
