Consequent to the DPC held on 12.05.2017 for the vacancy year 2016-17 and 2017-18 to fill up the vacancies in the grade of erstwhile Senior Tax Assistant existed prior to the notification of the new Recruitment Rules for the post of Executive Assistant in terms of Para 3 of Board's letter F.No.A32011/03/2015-AdIIIA dated 23.03.2017, the following Tax Assistants are promoted on **adhoc basis** to the grade of erstwhile Senior Tax Assistants (now re designated as Executive Assistants, Group B Non-Gazetted) in the entry pay of Rs. 35,400 /- (Index 1, Level 6 in pay matrix of 7th Pay Commission) plus allowances admissible from time to time, with immediate effect on an in-situ basis and their promotion will be effective from the date of their joining as erstwhile Senior Tax Assistant (re-designated as Executive Assistant).


03. All the promoted Officers will continue in their present place of posting till regular posting orders are issued.
