Consequent to the Annual DPC for the year 2018 held on 27.03.2018, the following erstwhile Deputy Office Superintendents (re-designated as Executive Assistants) are hereby promoted on regular basis to the grade of Administrative Officer (Group B Gazetted) in the pay matrix at the Level 7 (Rs.9300-34800 with corresponding Grade Pay of Rs.4600/- in 6<sup>th</sup> Pay Commission) as per 7<sup>th</sup> Pay Commission recommendation, with effect from the date mentioned against their respective names. Their promotion will be effective from the date they assume charge as Administrative Officers in their nominated place of postings.

2. The promotion now issued is subject to the condition that the officers concerned join latest by 10.04.2018 in their nominated place of posting failing which it will be treated that they have not accepted the promotion *ab initio* and all consequences arising as a result of non-acceptance of promotion shall follow.

3. Further, the Commissioners concerned shall ensure that if any of the officer whose name figuring in this promotion order is under suspension or facing any Disciplinary proceedings or prosecution or under penalty period, such officer should not be relieved or allowed to assume as Administrative

Officer. This fact may be brought to the notice of the Cadre Control Authority immediately.

4. The promoted officers may exercise their option for fixation of pay under FR 22(1)(a)(1) within one month from the date of receipt of this order. However, if the erstwhile Deputy Office Superintendents (re-designated as Executive Assistants) promoted have already been granted financial upgradation under Assured Career Progression Scheme / Modified Assured Career Progression Scheme, they are not entitled for any fixation benefits now.

05. The promoted officers who have not completed the training before promotion shall have to successfully complete the same within two years from the date of promotion otherwise they will not be considered for promotion to the post of Chief Accounts Officer. Officers with less than one year of service remaining before retirement on promotion, stand exempted from training.

06. Necessary compliance report regarding his relief / joining should be sent to this office by 16.04.2017.
