**Sub:- Preparation of panel for appointment of two (2) Senior Intelligence Officer (SIO) at Rourkela Regional Unit, Rourkela under Directorate General of GST Intelligence (DGGI), Bhubaneswar Zonal Unit on deputation basis.....Reg.**

The Directorate General of GST Intelligence, Bhubaneswar Zonal Unit is in the process of drawing a panel of willing and suitable candidates for filling up the existing vacancies as well as anticipated vacancy at Regional Unit, Rourkela in the grade of Senior Intelligence Officer (SIO) on deputation basis. As of now there is One (1) vacancy and One (1) vacancy (ies) will be arise on 01.04.2019 at the said formation. It is proposed to fill up these vacancies by appointing suitable officers from the grade of Superintendents in Customs and GST/Central Excise (Govt. of India).

2. The selected officer, while working in the Directorate General in the grade of SIO on a deputation basis, will be entitled for Deputation Allowance, as admissible. Normally, the deputation is for a period of five years which is extendable by another two years, subject to the willingness of the officer, his/her performance, and the concurrence of his / her parent Commissionerate and approval of the competent authority. It may be made clear to the willing officers that the option once exercised, would be final and in the event of selection, the will not be allowed to withdraw the same. Officers having minimum 3 years of experience in the grade may exercise their willingness through proper channel. Experience in Preventive / Anti-evasion are preferable.

3. It is requested that the circular may please be brought to the notice of all the formations under your jurisdictions and the applications of willing officers be forwarded to this office. While forwarding the names of the willing officers, the following information may be sent for evaluation by this Directorate viz.:-

- (a) Complete bio-data and willingness of the officer along with history of posting;
- (b) ACR/APAR grading for the last five (5) years duly verified and attested by the Additional /Joint Commissioner;
- (c) Vigilance Clearance Certificate;
- (d) "No Objection Certificate" from the Cadre Controlling Authority to relieve the officer in the event of his / her selection.

4. The above information/ details may please be arranged to be furnished to the Directorate at earliest, preferably by **08<sup>th</sup> November 2018**.
