Parmar judgement has been implemented from the revised panel drawn by the review DPC held on 15.05.2017 for the vacancy year 2011-12 (supplementary) for promotees who have been interspaced with the 2011 Direct Recruits. (Seniority No. 491 onwards)

5. **Inter Commissionerate Transferees:** The seniority of Inter Commissionerate transferees has been refixed in accordance to Para (ii) of Board's letter in F. No: A.22015/23/2011-Ad.III.A dated 27<sup>th</sup> October, 2011.


6. This seniority list contains the names of the promotees/ Direct recruits up to the vacancy year 2015 only.
