The Directorate General of GST Intelligence, Coimbatore Zonal Unit is in the process of drawing a panel of willing and suitable candidates for filling up the existing/anticipated vacancies at Zonal Unit, Coimbatore and its Regional Units at Madurai and Trichy in the grade of Senior Intelligence Officer(SIO) and Intelligence Officer(IO) on deputation basis. It is proposed to fill up these vacancies by appointing suitable officers from the grade of Superintendents/Inspectors in Customs and GST/Central Excise (Govt. of India).

2. The selected officers, while working in the Directorate General in the grade of SIO/IO on deputation basis, will be entitled for Deputation allowance, as admissible. Normally, the deputation is for a period of five years which is extendable by another two years, subject to the willingness of the officers, his / her performance, and the concurrence of his/her parent Commissionerate and approval of the competent authority. It may be made clear to the willing officers that the option once exercised would be final and in the event of selection, they will not be allowed to withdraw the same. Officers having minimum 3 years of experience in the grade may exercise their willingness through proper channel. Experience in Preventive/Anti-evasion is preferable. The Officers may indicate their preferences among the three locations.


3. It is requested that the circular may please be brought to the notice of all the formations under your jurisdiction and the applications of willing officers be forwarded to this office. While forwarding the names of the willing officers, the following information may also be sent for evaluation by this Directorate.

4. (a) Complete bio-data and willingness of the officer along with history of postings ;  
(b) ACR / APAR gradings for the last five (5) years duly verified and attested by the Additional/Joint Commissioner ;  
(c) Vigilance Clearance Certificate ;  
(d) "No Objection Certificate" from the Cadre Controlling Authority to relieve the officer in the event of his / her selection.

5. The above information / details may please be arranged to be furnished to this Directorate at the earliest, preferably by **10.02.2018**.
