Please refer to this office GST Trade Notice No.003/2018 dated 01.02.2018 communicating the details of jurisdiction of reorganized **Customs formations with effect from 15.01.2018** which will be handling the customs work in respect of taxpayers registered under the jurisdiction of Principal Chief Commissioner of GST & Central Excise, Tamil Nadu and Puducherry.
