ORDER NO 4 /2018

Sub: Implementation of Interim Order dated 13.03.2017 of Hon'ble High Court of Madras in WMP No.27508 & 27509 / 2016 in WP No.11580/2006 and Order dated 09.10.2017 passed by Supreme Court in SLP No.19808-19809/2017 filed by Shri M Jegannathan. Review DPC - Reg.

Consequent to the DPC held on 17.07.2002, promotion order to the grade of Superintendent was issued vide Order No.138/2002 dated 23.09.2002. The said DPC was reviewed on 22.01.2003 to implement the DOPT OM dated 11.07.2002. A review DPC was conducted on 21.12.2017 to review the DPC dated 22.01.2003 under the direction of Board's letter dated 11.09.2017 and 07.12.2017 to implement the interim Order dated 13.03.2017 of the Hon'ble High Court of Madras in WMP No.27508 & 27509/2016 in WP No.11580/2006 filed by Shri S Rajagoplan and Others and the Order dated 09.10.2017 of the Hon'ble Supreme Court in the petition for Special Leave to Appeal (C) Nos.19808-19809/2017.


2 Consequent to this present DPC, the promotion of i) Shri J Ramesh (Emp Code-4647) (expired on 23.07.2015, erstwhile Chennai-I Commissionerate), ii) Shri S Rajagopalan,(Emp Code 4607), SEZ, iii) Shri K Chandrasekaran(Emp Code-4251), SEZ and iv) Shri A Karunakar(Emp Code-4400), Chennai North to the grade of Superintendent is reckoned with effect from 23.09.2002 by retaining their positions of the panel dated 17.07.2002 (which constituted the basis of the promotion order dated 23.09.2002).

3. The officers are entitled for fixation of pay w.e.f 23.09.2002 in terms of FR22(1)(a)(i). However, if the individuals have already been granted financial benefits under ACP/MACP, they are not entitled for fixation of pay. The officers are not eligible for arrears of pay and allowances consequent to fixation of Pay if any.

4. Further, in the Zonal Seniority list of Superintendents, i) Shri J Ramesh (expired on 23.07.2015), ii) Shri S Rajagopalan, and iii) Shri K Chandrasekaran, will be placed below Shri K Sankaranarayanan(Emp Code-3538) and above Shri M V Mathimaran,(Emp Code-4475). Similarly Shri A Karunakar will be placed below Shri K Uthirapathi (Emp Code-5641) and above Shri Thirugnanasambada Moorthy (Emp Code-2686).

5. Further, this order is subject to final outcome of the Writ Petition Nos. 15368 and 15369 / 2005 filed by Shri M Jegannathan and WP No.11580 & 11581/2006 filed by the Department and also subject to the outcome of any decision in the cases pending before various judicial fora.
