
**LIMITED TENDER NOTICE**

1. Interested parties possessing the requirements as under may submit their quote to undertake the below mentioned work.

3. The quote should be for the below mentioned work.

4. Interested parties should possess the following **eligibility** criteria.
  - a) They should be registered with GST and should possess a PAN number and have a minimum of 5 years experience in similar nature of work; copies of GST Registration, PAN card and documents in support of work experience should be enclosed with the quotation.
  - b) They should have undertaken similar work for Central / State Govt. for a minimum period of 5 years and should have executed at least one single order for a value of more than Rs.2 Lakhs. Work completion certificates to be enclosed to the quotation, as proof.
  - c) No advance shall be paid and payment will be made only on completion of the work.;
  - d) The envelope containing the quotation should be super scribed as, QUOTATION FOR "REPAIR AND RENNOVATION OF WASHROOMS" and should be addressed to the Additional Director, Office of the Additional Director General(Systems), South Zone, Chennai-34. The quotation should be submitted in a sealed cover and should reach the undersigned on or before 019/03/2018 by 11.00 A.M.
