## CIRCULAR

**Sub: Appointment of Superintendent on deputation basis in the Directorate of Logistics, Customs & Central Excise, N. Delhi-reg.**

Attention is invited to circular of even number dated 28.11.2017 vide which nominations of willing officers for appointment to one post of Superintendent in the pre-revised pay scale of Rs. 9300-34800 + 4800/5400 Grade pay & Level 8/9 (as per 7<sup>th</sup> CPC) (likely to fall vacant on 21<sup>st</sup> March, 2018) in the Directorate of Logistics, Customs & Central Excise, New Delhi were solicited. All Group 'B' Gazetted officers in the analogous Pay Scale working in the Commissionerate/ Directorate/Custom House under Central Board of Excise & Customs are eligible for appointment on deputation to this post. The period of deputation is initially three years and can be extended by one year at the discretion of the Appointing Authority and for a further period of one year on mutually agreed basis.

2. Officers who apply for the said post will not be allowed to withdraw their candidature subsequently. However as and when a situation arises a premature reversion to his parent Commissionerate/Directorate may be given to the officer.

3. The names of suitable and willing officers along with their APARs grading for last five (5) years, Vigilance Clearance and History of Posting are to be forwarded to this office along with "No Objection Certificate" from the concerned Commissionerate/Directorate.

4. It is to be, now, informed, that the last date for submission of willingness has been extended upto 31.01.2018.
